PLEASE REVIEW THE QUALIFICATIONS FOR EACH SCHOLARSHIP

James W. Bryant, Sr. and James T. Collie Scholarship - Pittsylvania County Public school graduates, preferably students pursuing education or nursing.

Bernard C. Calvert Scholarship - Tunstall High School graduates, preferably students who attended either Brosville or Stony Mill Schools.

John Watson Daniel Scholarship - Graduates in Danville, Pittsylvania or Caswell County. Eligible students who are descendants of employees or retirees of John W. Daniel Construction Company may receive priority consideration.

Danville Regional Medical Center Auxiliary/Volunteers Scholarship - Danville Regional Medical Center employees and volunteers and their immediate families (current spouses, children, step-children or grandchildren), who are studying in a medical field.
