Gideon Miller was a native of Pittsylvania County who recently passed away on January 29, 2011. He received his Bachelor of Science degree in Business Administration from St. Paul College. Gideon was employed with Wachovia-Wells Fargo for nearly 23 years and served as a personal banker and Vice President in the Centerville office in South Boston.

Gideon was a faithful supporter of his family and his community. He served as the Treasurer of the 640 Community Rescue Squad. He was a member of the Longwood Small Business Advisory Board and was an active member of the Central Western Chapter of the Alzheimer Association. Gideon's past community involved included: Kappa Alpha Psi Fraternity, Halifax/South Boston Mentor Role Model Program, Halifax County United Way and Budget & Allocation Committee. He also served for eight years on the Danville Community College Board of Directors.

Gideon's brother, Dexter Miller, has been instrumental in starting the Gideon Miller Cancer Fund. "This is something he really wanted done," said Dexter. "Gideon was really concerned for the other patients he saw while receiving treatments."
