## THE COMMUNITY FOUNDATION OF THE DAN RIVER REGION ANNOUNCES \$681,461 AWARDED IN NEW COMPETITIVE GRANTS

The Community Foundation of the Dan River Region announces today a total of **48** new grants to non-profit community agencies. The grants, totaling **\$681,461**, are the result of The Community Foundation's 2021 competitive grant cycle.

Approved by The Community Foundation's Distribution Committee and Board of Directors, the grants were awarded from the Community Impact Fund, Danville Regional Foundation Fund, Field of Interest Funds, and Donor Advised Funds. The Community Impact Fund is composed of the following unrestricted funds: James Russell Anderson and Zora Carter Anderson Fund, Buck-Wayland Fund, Faith Home Endowment Fund, Clarence L. Giles Fund, Harry Melton Hood Fund, Elizabeth (Betty) W. Jefferson Fund, D. Webster, Jr. and Elizabeth S. Marshall Fund, The Opportunity Fund, James A. and Anne V. Robertson Fund, Barbara H. Sater and Herbert W. Sater Memorial Fund, and John C. Swanson, Jr. Fund.

The following grants are listed in alphabetical order by grantee name, amount of grant, and purpose of grant:

American Red Cross (\$14,768) to cover the cost of holding blood drives in Danville and Pittsylvania County and cover the specialized and time-sensitive additional cost of COVID-19 antibody testing (Community Impact Fund)

**Big Brothers Big Sisters of Danville Area** (\$7,000) to market the need for mentors to serve at-risk youth and hire mental health professionals to train and support the mentors/families (Danville Regional Foundation Fund; Community Impact Fund)

**Blairs Fire & Rescue** (\$14,980) to purchase replacement firefighter turnout gear (Danville Regional Foundation Fund)

**Boys & Girls Clubs of the Danville Area** (\$10,000) to support the purchase of temperature scanning kiosks, hand washing stations, program material and supplies and vital cleaning supplies and services that must be implemented due to COVID (Community Impact Fund; Faye Carter Fund)

**Caswell Cancer Resource Fund c/o Caswell Family Medical Center** (\$37,200) to provide cancer patients in Caswell with direct financial support to help with medical transportation, medical and pharmacy copays, nutritional supplements, durable medical equipment and support groups/education (Danville Regional Foundation Fund; Community Impact Fund)

**Caswell County Parish** (\$25,000) to assist families who are in danger of having their electrical service terminated or who do not have the means to purchase needed heating fuels such as oil or propane or wood (Danville Regional Foundation Fund; Community Impact Fund)

**Caswell County Partnership for Children** (\$3,400) to provide Kindergarten Transition and Family Engagement learning kits to children participating in the NC Pre-K program (Gamewood Technology Fund)

**Changing Lives Outreach Center CDC** (\$5,000) to purchase food for Project Feed 500 (Community Impact Fund)

**Dan River Basin Association** (\$9,135) to develop and provide virtual programming that has the same interactive, positive outcomes as their award-winning in-classroom and outin-the-field EE programs (Danville Regional Foundation Fund; Community Impact Fund)

**Second Harvest Food Bank of Northwest NC** (\$15,000) to purchase additional food for seniors and children who have been hit hard by the COVID-19 pandemic and its ramifications (Community Impact Fund)

**Special Olympics NC** (\$2,500) to purchase health and fitness equipment, award recognition for athlete participation, as well as office supplies, printing fees, and technology needed for at-home workouts (Community Impact Fund)

**St. Luke's United Methodist Church** (\$6,952) to host programs at St. Luke's that will promote healthy lifestyles for members of the community as well as to hold a forum on participation in the THRIVE! initiative by area faith-based organizations (Stratford House Fund)

**The Danville Museum of Fine Arts and History** (\$21,282) to support three months of funding to help pay operational costs during this time when it is difficult to fund raise and difficult to access state and federal grants without a two-year track record of competitive museum programming (Danville Regional Foundation Fund; Mary Cahill Historic Preservation Fund; Community Impact Fund; The Daniel Fund)

**The Doorways** (\$5,000) to provide direct service to the Foundation's residents who must travel to Richmond often for weeks and months at a time to access prescribed medical care that is not available in their communities (Community Impact Fund)

**The First Tee of Caswell County/Danville (Triad)** (\$6,500) to provide scholarships to 50 participants throughout the 2021 programming year, including Spring and Fall seasons, conducting three outreach experiences and opportunities, and extending the National School program, reaching the remaining Pittsylvania County schools and all Caswell County elementary schools (Community Impact Fund)

**Virginia Dental Association Foundation** (\$3,000) to provide case management for the DDS program in Danville and Pittsylvania County (The Free Clinic of Danville Fund)

**Virginia Legal Aid Society, Inc.** (\$25,000) to help pay a portion of the legal professionals in the Danville office to help low-income residents of the Dan River Region preserve safe and affordable housing (Community Impact Fund)

**Yanceyville Volunteer Fire Department** (\$12,165) to add technical rescue capabilities and upgrade communications on Yanceyville's Ladder Truck that serves all ten Caswell County Fire Departments and Danville/Pittsylvania County under automatic mutual aide agreements (Danville Regional Foundation Fund)

The Community Foundation's next competitive grant cycle begins in June 2021 for projects to be funded in 2022. The Community Foundation of the Dan River Region is a public charity established in September 1996 by a steering committee of civic leaders to improve and enrich area lives through the generosity of donors.
