## **Inspiration and Impact**



#### Vision

To recognize needs and provide resources to improve the quality of life in our community and to serve the wishes of our donors.

#### Mission

To improve and enrich the lives of people in our community by encouraging the generosity of donors; by receiving, managing and distributing important resources; and by meeting a variety of charitable purposes in our community.

#### What It Is

The Community Foundation of the Dan River Region (CFDRR) was established in 1996 by a steering committee of local civic leaders to gather and manage permanent funds to enhance quality of life in the region. CFDRR is dedicated to responsible and effective community philanthropy. Community Foundations are fundamentally tied to a specific geographic area, where they work to serve the interests of donors, residents, and the community at large. For CFDRR, the defined local geographic includes Danville and Pittsylvania County, Virginia and Caswell County, North Carolina. Resources are also being sought for South Boston/Halifax County, with consideration being given to other neighboring counties. To meet the varied philanthropic needs of their donors and the communities they serve, The Community Foundation offers a range of fund types and services. The Community Foundation is a fully tax-exempt, public charity described in Sections 501(c)(3) and 170(b)(A)(vi) of the Internal Revenue Code.

### **How it Works**

The Community Foundation of the Dan River Region accepts contributions, including cash, stocks, and other types of investments. These funds are pooled and invested under the direction of a Board of Directors composed of community leaders. Income from the funds is distributed annually in the form of grants and scholarships. To date, CFDRR has gathered assets of more than \$50.9 million and awarded more than \$27.1 million in grants and scholarships.

## Ways To Give

#### Establishing a Fund

- A straightforward and simple process.
- We offer several types of funds: Unrestricted, Donor Advised, Field of Interest, Scholarships, Designated Funds and Agency Funds.
- The required establishing gift for an endowed fund is \$10,000 and \$25,000 for a scholarship.
- If an individual or organization should require time to grow their fund balance to reach this minimum, we offer an Acorn Fund, which provides the donor a three-year period to attain the minimum required fund balance, at which point the fund becomes endowed.
- Donors are welcome to contact our office anytime for more information on establishing and administering a fund.






