Message From the President



The Community Foundation of the Dan River Region just finished its 22nd year - "Moving Forward, Giving Back" - a year in which we continued to establish and manage permanent endowments and donor advised funds which allow us to help meet the needs of our local communities. From its inception as a brand new community foundation in 1996, the Community Foundation of the Dan River Region has emerged as the 8th largest community foundation in Virginia with more than \$36 million in assets.

Each year the Foundation awards both grants to nonprofit organizations and scholarships to students in the Dan River Region. Since its creation, the Foundation has awarded more than \$22 million in grants and scholarships. This past year 2017-18, the Foundation awarded \$196,515 in scholarships to 100 students and more than \$1 million in grants. The Community Foundation of the Dan River Region supports projects in the community through special funds such as the Veterans Memorial Fund, the RiverBank Fund and the new Pet Center Fund. For some of these funds, we have been actively involved in raising money in addition to managing the fund.

We are grateful for the trust and respect demonstrated by the generosity of individual donors, companies and other non-profit agencies. It is because of our donors that the Foundation continues to grow and be a more

significant partner supporting our communities. In addition to managing funds and awarding grants and scholarships, the Foundation hosts a quarterly meeting with all the major area foundations and other charitable funding sources with a collaborative goal of understanding the needs in our communities and striving to fund those needs. The Foundation will be experimenting this year with offering educational teleconference presentations to professional advisors in the area to further their educational needs. The Foundation will continue to reach out in the areas we serve - Pittsylvania, Halifax, Caswell Counties and the City of Danville - sponsoring luncheons to thank those who have established funds in the past and offer opportunities for those who may wish to create new funds or simply donate to existing funds.

We continue to operate with a "lean" hard working and highly qualified staff including the Executive Director for the past 19 years - Debra Dodson, Morgan Epstein, Program Officer, and Annette Roncaglione, Donor Services Manager. Our current Board of Directors has 21 professionals and community leaders who represent the communities we serve. They stand on the shoulders of former volunteer board members and officers, hoping only to equal the exceptional leadership provided over the past 21 years. This year, the Community Foundation of the Dan River Region looks forward to making new friends who wish to become a part of the lasting legacy of support and hope in our communities providing for the needs and meeting the challenges we face.

What is the Community Foundation?

The Community Foundation of the Dan River Region is an independent, public charity established in September 1996 by a steering committee of local civic leaders to gather permanent funds to support our area.

While the Foundation works with donors to establish funds to benefit any geographic area, our primary service area is Danville/Pittsylvania County, Virginia and Caswell County, North Carolina. Donations are also being sought to build up resources for South Boston/Halifax County, with consideration being given to other neighboring counties.

Each community foundation is fundamentally tied to a specific geographic area, where it works to serve the interests of donors, residents, and the community at large. To meet the varied philanthropic needs of their donors and the communities they serve, community foundations offer a range of fund types and services.

The Community Foundation is fully tax-exempt as an organization described in Sections 501(c)(3) and 170(b)(A)(vi) of the Internal Revenue Code.

Legacy

An important part of our work is building a collection of legacy endowment funds for our community. If these objectives ever become impossible to carry out, the Board will redirect the funds to support a closely related purpose.

Pittsylvania Animal Shelter Fund

The Pittsylvania County Animal Shelter Fund was opened in 2008 by a private donor. During this past year, The Community Foundation accepted donations through the Fund to support the new Pittsylvania County Animal Shelter on Route 29 in Blairs. Donors can continue to help build an endowment for long-term support of the Center through gifts to the Pittsylvania County Animal Shelter Fund.



Investments at a Glance

The prudent and strategic investment of assets is central to our responsibilities. Our capacity for serving the community is directly tied to our ability to conserve capital and secure a positive return. The end result guides our ability to enhance the quality of life in the communities we serve.

Asset Allocation & Philosophy

Making sound strategic decisions on the structure of a portfolio has a profound influence on investment results which is why the Foundation has a diversified portfolio with a long-term time horizon. The portfolio is invested in accordance with a core principle of successful investing which acknowledges that a diversified portfolio across different asset classes should provide a sustainable rate of income while minimizing the volatility that affects all investments to varying degrees. The portfolio is periodically rebalanced to target allocations to maintain portfolio equilibrium, increase value and support donor's spending over the long term.

Process & Governance

The Foundation's portfolio is reviewed by the Finance Committee and the Foundation's independent investment consultant on an on-going basis. The Investment Committee and investment consultant review:

- Strategic Investment Opportunities
- Portfolio Allocations
- Fund Manager Analysis
- Investment Performance
- Manager Searches (as needed)
- Market Environment
- Capital Market Assumptions

The Investment Committee and our investment consultant recognize that we must avoid focusing on the short term which always plays out randomly and unpredictably and instead look forward over the long term where we can achieve a reasonable degree of certainty. We will continue to focus on a sound investment policy for the benefit of our donors and will continue to employ best practices as we oversee the Foundation's investments.

Starting a Fund

Donors can create their own named fund for a minimum of \$10,000 (\$25,000 for scholarships) or they can contribute in any amount to an existing fund of the Foundation.

We invite you to join the thousands of donors who are working through The Community Foundation to build a strong future for our community.

Perhaps you have had a lifelong commitment to a particular charitable field and wish to support that interest in perpetuity. You may have a specific charity or charities in mind to receive income from your fund – or you may prefer an unrestricted gift, allowing the Foundation to determine where needs and opportunities are greatest in the community. You, and perhaps your family, may choose to be involved as advisors to a fund.

The Community Foundation encourages potential donors to also consult with their attorneys, accountants and tax advisors to learn more about charitable giving and establishing a fund through estate planning.

Unrestricted Funds give the Foundation maximum flexibility to respond creatively and effectively to the community's most compelling needs and opportunities. These funds are among the Foundation's most important assets, capable of addressing community needs as they change over time.

Field of Interest Funds are restricted by the donor at the time of creation to support a particular area of interest, such as children, the elderly, the arts, or the environment, etc. Once established, Field of Interest funds can grow through gifts from others who see them as a way to address their own charitable interests.

Designated Funds enable donors, at the time funds are established, to name one or more specific organizations to benefit from the fund permanently. The Foundation ensures that the designated recipients receive support as long as they remain in existence and continue to fulfill the intended charitable purpose.

Donor Advised Funds allow donors to recommend which charitable organizations should receive grants from their fund and in what amounts. Many donors choose to give to multiple nonprofits through a donor-advised fund. Our board of directors is legally responsible for approving all grants.

Scholarship Funds allow our donors to invest in the future by helping deserving students in our community. As the donor, you determine the criteria students must meet to receive your scholarship. Your gift can help students – from preschool to postgraduate – achieve their lifetime dreams. The Community Foundation provides the expertise to handle all of the application and selection process.

Agency and Church Endowment Funds allow nonprofit organizations (agencies) or houses of worship to create a permanent and predictable source of funding dedicated for their organization or other charitable organizations. The agency can add to the fund as well as individuals, organizations and businesses.

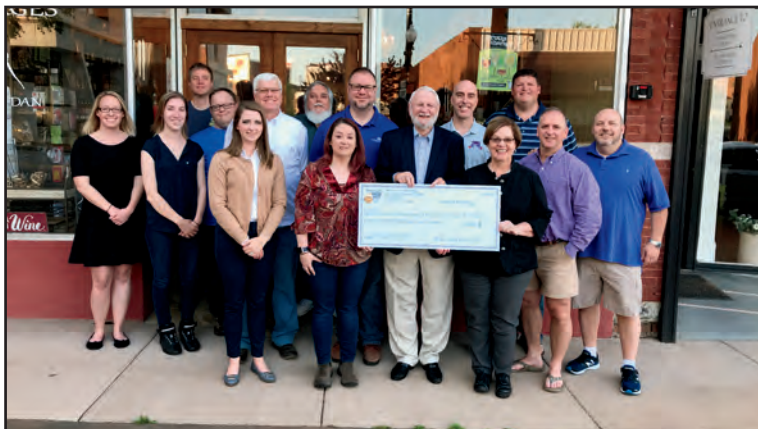

UNRESTRICTED AND FIELD OF INTEREST

Unrestricted grants were awarded from Funds whose purpose is unrestricted. Field of Interest grants were awarded from Funds established by donors wishing to support a particular field of interest, such as youth, arts and culture or humanitarian causes.

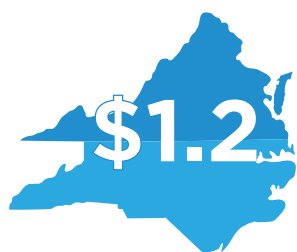

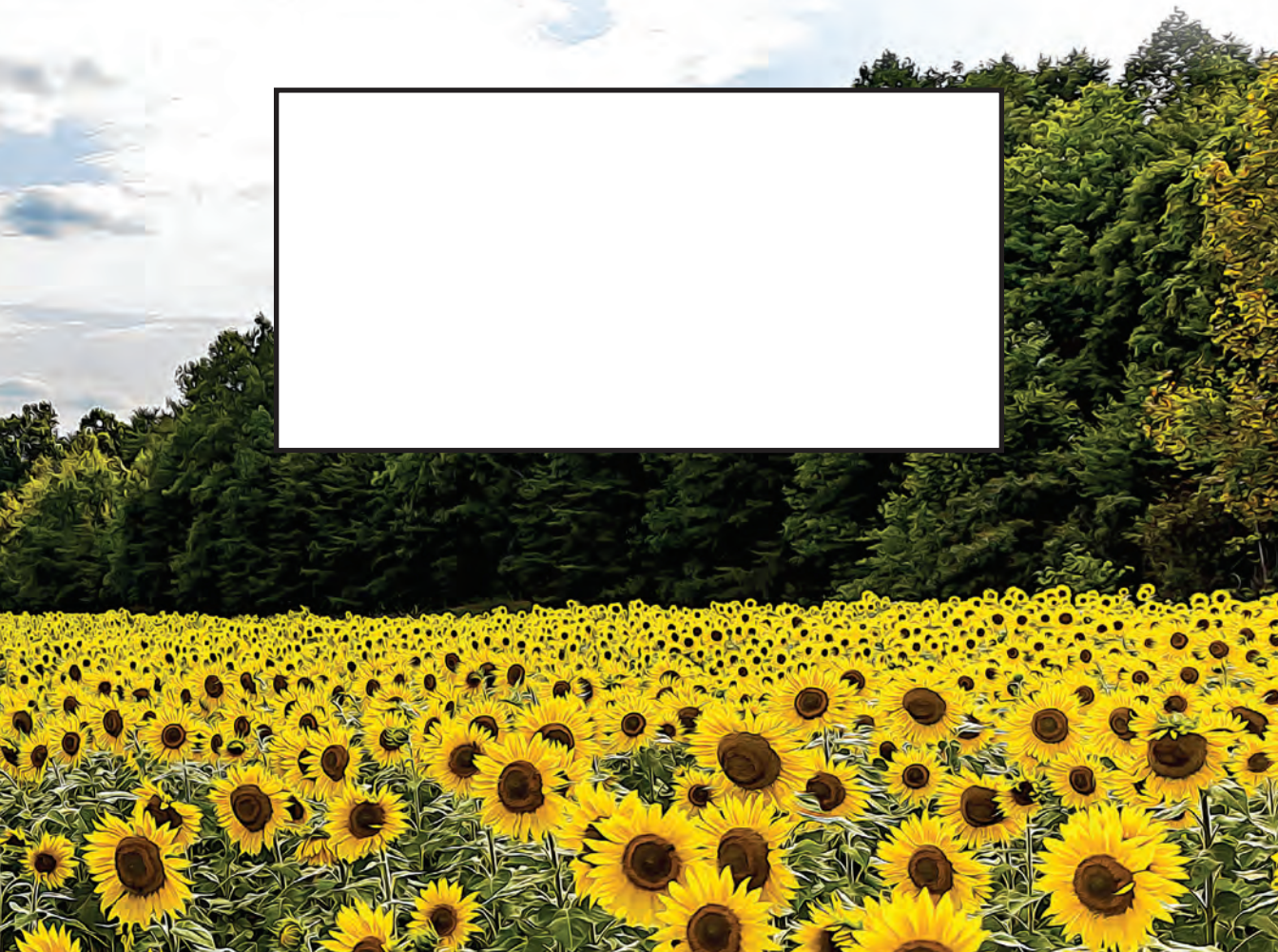
