

The Community Foundation's Competitive Grants are Awarded from the Community Impact, Field of Interest and Donor Advised Funds

The Community Impact Fund is made up of the following unrestricted funds: *The Daniel Fund, James Russell Anderson and Zora Carter Anderson Endowment Fund, Buck-Wayland Fund, Faith Home Endowment Fund, Clarence L. Giles Fund, Harry Melton Hood Fund, Elizabeth (Betty) W. Jefferson Fund, D. Webster, Jr. and Elizabeth S. Marshall Fund, James A. and Anne V. Robertson Fund, Barbara H. Sater and Herbert W. Sater Memorial Fund, John C. Swanson, Jr. Fund, The Opportunity Fund and Unrestricted Community Fund.*

Field of Interest Funds allow donors to specify an area of interest, such as youth, elderly, the arts, education, environment, or medical, to be supported by the fund. Smokestack Theatre Company hosted
Summerstack Programs in the summer months
to introduce youth to the "magic" of theater.
Kids ages 7-11 learned theater basics, created
take home crafts including a costume, prop and
set diorama. The end of the camp provided an
opportunity for the kids to perform for their
parents. Eleven campers were invited to
audition for the Summerstack Youth Production,
Channeling Grimm, where 22 children
performed four shows for over 330 attendees.
Kids gain developmental skills such as public
speaking, memorization, vocal projection and
teamwork.

Thirteen youth, ages 10 to 17, from the Hughes Residential Treatment Center received three hours of Equine Assisted Activities to promote their physical, social and emotional needs through the Good Hope Equestrian and Regenerative Farm. The activities included horseback riding, care and maintenance of the horses and facilities.

The youth participating in the program present a range of diagnosed conditions, including autism, developmental delays, learning disabilities, as well as emotional conditions such as anxiety, depression, post-traumatic stress disorder and reactive attachment disorder. The Equine Therapy helps the development of strength, coordination, fine and gross motor skills, confidence building along with helping enhance social skills and emotional well-being.

Eighty-five percent of the Hughes Center youth experienced improvements in relaxation, reconnection, enjoyment and a reduction of symptoms related to anxiety and depression. Eleven youth displayed positive changes in their behavioral conduct.

The Gretna Branch Library recently underwent a complete renovation that included the creation of a welcoming and educational learning outdoor space. A stage area is completed and includes shades, electricity, and an area for people to sit and enjoy outdoor performances. There is also a music maze equipped with instruments and a walking trail where native plants can be studied. There are also picnic tables with electric outlets built in so patrons can bring laptops and work outside with using wifi. The hope for this project is increased use for middle and high school students.

Blairs Fire and Rescue has a tagline, "So Others Can Live." The agency was able to replace a failing boat with two 14 foot rescue boats with 40 horsepower motors and a transport trailer that carries both boats. Frank Dean Fowler told us that he is relieved to know that when he has to send volunteer personnel into a situation where they are forced to make life or death decisions, his people have the safest equipment to do the job. "The Community Foundation of the Dan River Region, in partnership with the Danville Regional Foundation, has no idea how many lives have been changed because of the financial support given to allow for compliant equipment and training for personnel," says Frank Dean Fowler, Fire Chief.
